WAIVER & LIABILITY RELEASE AGREEMENT

1. Sportsline, SkateSports and/or AIHS shall be referred to hereafter a "the Provider";
2. In consideration of being allowed to participate or spectate in any way in Inline hockey, related events and activities, or any other service or event associated with the Provider the undersigned acknowledges, appreciates, and agrees that:
 - i. **The risk of injury from Inline Hockey tournament is significant including the potential for permanent paralysis and death. While particular rules and equipment, and personal discipline may reduce risk, the risk of serious injury does exist and is a common and ordinary occurrence!**
 - ii. I have of my own desire and free will undertake to use the services and/or equipment of the Provider and I agree to **FULLY INDEMNIFY AND HOLD HARMLESS** the Provider, its servants and agents from all claims, demands, actions and suits which at any time hereafter be brought by any such person caused by or arising out of or in any way related to using the Provider's services and/or equipment.
 - iii. **I knowingly and freely assume all such risks**, both known and unknown, even if arising from the negligence of the releases or others, and assume full responsibility for my participation or that of whom I am signing for as the legal guardian of a minor.
3. I grant full permission to the Provider to use recorded media of any form of myself or a minor that I am signing on behalf of, for any legitimate purpose and **waive any ownership of, or rights to**, said media.
4. I willingly agree to comply with the stated and customary terms and conditions for participation if however I observe any unusual significant hazard altering my presence or participation, I will remove myself or a minor whom I have signed for, from participation and bring such to the immediate attention of the nearest official.
